IN ADDITION, THE ASSOCIATION PRESENTS A VARIETY OF REGIONAL AND NATIONAL TOURING MUSICAL ACTS AND THEATRICAL PRODUCTIONS, AND PROVIDES A RENTAL FACILITY FOR ADDITIONAL PRODUCTIONS WHO NEED PERFORMANCE SPACE.
