THE ASSOCIATION ALSO PRESENTS SENIOR PRODUCTIONS, WITH ONE-ACT PLAYS WRITTEN FOR SENIOR ACTORS AND PERFORMANCES THAT ARE HELD DURING THE DAY. IN ADDITION, AAAA OFFERS THREE SUMMER PRODUCTIONS FOR STUDENTS IN GRADES 3-12, AN IMPROV COMEDY TEAM AND PROVIDES RENTAL FACILITIES FOR ADDITIONAL PRODUCTIONS THAT NEED PERFORMANCE SPACE.
